### Birthday Parties

Our Basic Party Package includes:

- One Hour of an Event/Activity
- One Hour Party Room Rental
- Host/Hostess for the duration of the party

**Fees: \$75.00 per hour for up to 25 children** (for each additional 25 children add a \$10.00 fee per hour)

**A \$50.00 deposit is required at the time of booking for any party/rental.** This is then subtracted from the remaining balance of the rental.

### Overnighters

(7pm to 7am)

Our Basic Package Includes:

- Two Hour Rental of the Pool and Climbing Wall
- Party Room Rental for the Night
- Host/Hostess for the duration of the Overnighter

**Fees: \$20.00 per person with a minimum of 25 people.**

**A \$100.00 deposit is required at the time of booking for any overnighter.** This will then be subtracted from the total owed for the rental.

## Pool Party Information & Rules

If you are looking for an event that will satisfy children of all ages, a pool party is the perfect decision. At the Y we will go out of our way to help ensure that your pool party runs smoothly and time effective. If you're looking for a splash of fun, a Y pool party is the right choice for you.

- All group rentals, overnighters, after proms, and birthday parties are held in the main pool. (25 yards, approximately 80-82 degrees)
- Please keep ratios in mind while swimming at the Y. A ratio of 1 adult for every 5 swimmers age 7 and under, and 1 to 5 adults for non swimmers, is requested.
- We do not allow inflatable toys or flotation devices in the water. Coast guard approved lifejackets are acceptable. (These are provided by the Y)
- Participants who normally wear diapers are required to wear both a disposable swim diaper and rubber pants.

## Moon Bounce Parties

If you're looking for something different, a Moon Bounce party at the Y is just the answer. This is the perfect option for children under 12 years of age. The Moon Bounce is now in it's own private room so the hustle and bustle of our busy Y will not disturb your party. Kids gym equipment can also be set up based on gym availability. This private room is only steps away from our party room. Our staff will help facilitate this party to ensure that there is not a dull moment. Sit back and relax, and let the Y take care of the rest.

## Climbing Wall Parties

Wondering where you can find a challenging yet exciting and fun event, indoors? The Y is the place. Our indoor rock climbing wall offers 1100 square feet of climbing. It offers various routes for beginners, intermediate climbers, and advanced climbers. The Y provides helmet and harnesses for all sizes. All participants are required to review the wall climbing rules and sign a waiver before they will be permitted to participate. Anyone under 18 years of age must have a parent/guardian signature.
